The FY 21 increases expenditures by \$18,050.00. The increase reflects increased election costs as the BOFC anticipates mailing ballots to all voters during the coming election cycle. The cost of the LOSAP program have increased as the district has enrolled additional firefighters. The budget does not exceed the cap and provides for no increase in the municipal tax rate. The budget does not anticipate the purchase of any new apparatus.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

The election expenses increased from \$750 to \$6,500. This reflects increased costs for printing and mailing ballots to all registered voters in the district. The LOSAP program costs increased \$10,000 from \$60,000 to \$70,000. This reflects an increase in fire company membership.

The amount to be raised by taxation will increase from \$962,546 to \$970,540, an increase of 1.8%. The tax rate will remain as in the FY 20 year due to the increase in rateables.

The BOFC passed a resolution releasing \$15,000.00 from the LOSAP restricted fund balance for the purpose of funding increased LOSAP costs in the coming year. The LOSAP restricted fund balance was significantly increased in 2020 as the BOFC received a return of contributions from former members who did not vest.

The BOFC budget does not propose any capital appropriations in the budget, nor does it include any debt service. The BOFC has no debt service obligation from any prior year. The BOFC continues to appropriate funds to place in the restricted capital account for the purchase of future apparatus. Also, new Mobile radios and pagers are in the long term capital plan to switch to the 700/800 as per FCC guidelines and these funds will help support that within the next 2-4 years.


