WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,242,280.00 which includes an amount to be raised by taxation of \$1,056,500.00 and Total Appropriations of \$1,242,280.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 23, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The FY25 budget increases non capital expenditures by less than \$20,000. The annual appropriation to the capital fund is increased to reflect the rapid increase in the costs of replacing fire apparatus, consistent with the BOFC long range capital plan.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Election expenses are increased by 23% (\$1500) to reflect the increased cost of mail in ballots for the annual election. Adjoining municipal services costs are reduced by 12.5% to reflect FY24 actual expenses. Utility costs are increased by 22.2% (\$2,000) to reflect actual expenses from the prior year. Fuel costs are increased 16.7% (\$2,000) to reflect actual expenses in the prior year. LOSAP appropriation is increased by 10% to reflect increased participation in the program.

The FY25 budget complies with the property tax levy cap. The unrestricted fund balance is not decreased by more than 10%. The amount to be raised by taxation is increased by 2%.

5. Does the Fire District plan on exceeding the Levy Cap? If so, please provide a statement with the reasons for exceeding the Levy Cap and identify the appropriations that caused the Fire District to exceed the Levy Cap, and how they are being addressed by a referendum.

The BOFC proposed budget does not exceed the levy cap.

6. If the Fire District plans to pass a Resolution for the Release of Restricted Fund Balance to be used in the 2025 proposed operating budget, explain the reason and purposes of the appropriation.

The BOFC received voter referendum to release \$90,000 from the capital restricted fund balance to purchase a fire police response vehicle. Upon approval of the budget in February the new apparatus should be delivered in the fall of 2025.

The FY25 budget appropriates the sum of \$90,000 to complete the purchase of a fire police response vehicle to replace a vehicle that is 20 years old. The BOFC has no debt and this expenditure does not require debt service appropriation.
