The FY23 budget increases expenditures by just \$20,191 over the FY 22 budget and is compliant with the levy cap.

3. **Explain any variances over +/-10% for each line item.** Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

The medical account increased by \$2,500 (29.4%) reflecting increased costs. The Repair and Maintenance account increases by \$6,000 (10%) again reflecting the increased cost of repairs. The BOFC increased it's support to adjacent municipal fire department by \$1,750 (43.8%) to assist with increased operational costs. The budget for Fuel increased \$3,000 (33.3%) reflecting the higher cost of fuel. The Testing and Inspection line increased \$1,500 (15%) reflecting increased costs. The Other Operations line was reduced by \$8,500 (36.2%) and the monies were re-allocated to other lines. The Other Equipment line was reduced by \$6,550 (16.9%) and the monies were re-allocated to other line items. The Advertising line was reduced by \$270 (21.3%) reflecting actual costs. The Training and Education account was reduced by \$18,000 (28.6%) as the BOFC approved less out of state travel to training events. On the Revenue side the Interest income line was increased by \$3500 (233%) reflecting the increase in national interest rates. Delayed delivery of the aerial apparatus approved last year due to supply chain issues will leave the funds approved for that purpose to earn interest for the coming year.

The FY23 increases the amount to be raised by taxation by \$20,191 and is compliant with the property tax levy cap. The unrestricted fund balance is not reduced by more than 10%.

The proposed FY 23 budget does not exceed the budget cap.

The BOFC seeks to use the sum of \$300,000 from its Restricted Fund Balance. The sum of \$150,000 will be used to replace a brush truck and the sum of \$150,000 will be used to purchase updated radios.

The BOFC expects to use the sum of \$300,000 in capital appropriations from its Restricted Fund Balance as described above. The BOFC will not borrow any monies for this purpose and will therefore have no debt service.
